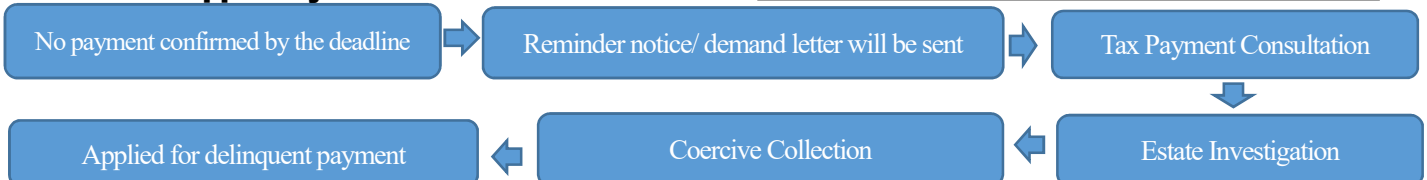
Tax Payment

- Tax Payment Consultation at Night
Every Wednesdays: until 7pm/ November 6th, 13th, 20th, 27th, December 4th, 11th, 18th, 25th
- Sunday Tax Payment: 8:30am-5:00pm/ November 3rd, December 1st
- You can make a payment at convenience stores within the deadline with your tax payment slip. Please be careful that you cannot pay at convenience stores after the deadline.
- Tax payment is an obligation for the people in Japan.

Notification: Months of Childcare Allowance Payment will be changed

Fujinomiya City had granted childcare allowance for 4 months at a time on April, August and December. From November 2019, it will pay your childcare allowance for 2 months every odd month. Therefore, eligible persons will get allowance for 3 months (from August 2019 to October 2019) on November 2019 and will be granted benefits for 2 months from January 2020.
