■Convenience Stores

Payments can be made 24 hours a day.

- Payments cannot be made after the due date.
- When making multiple payments at once, please check the total amount.



■Smart Phone Payment Apps

You can make payments anytime, anywhere, 24 hours a day, 365 days a year by scanning the eL-QR or the barcode on the payment slip.

Caution

- Payments cannot be made after the due date.
- Paper receipts are not issued.
- Once payment has been made, it cannot be cancelled, please be careful not to pay twice.
- You can check which apps are eligible for this service on the "eLTAX website".

Child Support Allowance for single-parent families, etc.

The Child Support Allowance (*jido fuyo teate*) will be provided to parents or caregivers whose children meet one of the following conditions. There are certain conditions, such as income limit, etc.

- Parents have divorced.
- Father or mother ①died, ②life or death unknown, ③detained for more than 1 year, or ④under a DV protection order.
- Abandoned by father or mother for more than 1 year.
- Father or mother has a severe disability.
- Born out of mother's wedlock.

※The monthly allowance amount will be increased by 2.5% from April.

※Eligible until the first March 31st of the child's 18th year old.

Child-Raising Support Benefits

Benefit of **10,000 yen per child** will be provided to support the livelihood of households raising children.

Eligibility Those who have a residence in the city as of January 1, 2023 and who are raising a child born between April 2, 2004 and April 1, 2025.

Application If you meet one of the following conditions, you must submit an application form (available on the city's official website) by mail, online, or at the counter by June 30 (Fri).

- ①Those who are not eligible for Child Allowance due to income limits or other reasons.
- ②Parents or caregivers of a child born between April 2, 2004 and April 1, 2007.
- ③Civil servant

Others Those who received the Child Allowance for January 2023 from Fujinomiya City (excluding civil servants) do not need to apply for the benefit, as it will be transferred to their registered bank account for the Child Allowance.

Education assistance for elementary and junior high school students

Subsidies will be provided to families with elementary or junior high school students who are having difficulty paying education expenses (school lunches, school supplies, etc.) for financial reasons.

Eligibility Those who receive the Child Support Allowance (*jido fuyo teate*) or are exempted from municipal resident tax.

Application Submit the application form (available at the school) to the school office.

※Those who moved to Fujinomiya City after January 2022 and do not receive the Child Support Allowance will be required the certificate of income tax, etc.

Pneumococcal Vaccination for adults

Pneumococcal Vaccine for adults is effective in preventing the onset and severity of pneumonia, bronchitis, sepsis, and other diseases.

Once in a lifetime, you can receive either a routine or voluntary vaccination with public subsidy.

【Routine vaccination】

Eligibility Those who are eligible will receive the notice in April.

Fee Copayment 3,300 yen (free of charge for public assistance recipients)

Application Please see the notice.

【Voluntary vaccination】

Eligibility Those 65 years old and over are not eligible for routine vaccinations.

Fee The cost of the vaccination, excluding the 3,000 yen subsidized by the city

Application Please contact us in advance.



Others Please contact us in advance if you will be vaccinated at a medical institution outside of the city.

We will implement vaccinations twice a year, in spring - summer and fall - winter. Vaccinations can be received after the 2nd, 3rd, 4th or 5th vaccination and 3 months have passed since the last vaccination.

Those 65 years old and over or those with the disability certificate can take a shuttle taxi (free of charge) to the mass vaccination venue.

To use this service, membership registration and a reservation with the taxi company at least one week prior to the date of vaccination are required.

Vaccinations against Omicron strain

Those who have not been vaccinated against the Omicron strain can be vaccinated at medical institutions in the city.

Through basic infection control measures

COVID-19 is ranked as the "Pandemic Influenza" (equivalent to Category 2) due to its infectiousness and severe symptoms when it occurs, but will be downgraded to "Category 5" from May 8, 2023. After that date, the risk will remain the same, so please continue to take infection control measures
