Notice Welfare Loan Program for single-parent families

The prefectural government provides interest-free loans to single-parent families whose children will be enrolled in high school, university, or vocational school from April 2024.

The maximum amount varies depending on the type of school, public or private, and the conditions of attendance, etc.

School fees

Tuition, Textbooks, Commuting fees, etc.

Enrollment fee, etc.

Preparation fees to enroll in high school, university, or vocational school

Eligibility Children from single-parent families / Children who do not have parents

Application From November 1 (Wed), Application forms will be available and accepted at the counter of the Child Future Division on the 1st floor of City Hall.

Others Interviews will be held at a later date. This loan program cannot be provided to students who are receiving scholarships from the "IKUEIKAI "or other organizations.

Notice Child Medical Expense Subsidy System

If you have the "子ども医療費受給者証(Child Medical Expense Beneficiary Certificate)", you can receive subsidies for medical treatment covered by insurance.

How to Receive Medical Expense Subsidies

When you visit a medical institution, please show your insurance card and "うども医療費受給者証(Child Medical Expense Beneficiary Certificate)".

Co-payment for **Visiting a doctor**: 500 yen per visit (up to 4 visits per month) Co-payment for **Hospitalizations**: none (excluding for extra charge for a private room) Co-payment for **Prescriptions**: none

Please apply for it at the Child Future Division on the 1st floor of City Hall.

Notice Medical Expense Subsidies for single-parent households, etc.

When you receive a medical treatment covered by insurance, we will subsidize the full amount of your copayment.

Eligibility Households that meet one of the following conditions and whose income during 2022 is not subject to income tax.

①Parents from single-parent households and who support children under 20 years old, and their children ②Children under 20 years old who have no parents

③Children under 20 years old whose father or mother is severely disabled or who are unable to receive support due to their prolonged detention or disappearance

What to bring

-Bankbook in the name of the parent/guardian

- -Insurance cards of all household members
- -My Number(individual number) of all household members

National	Deduction Certificate for Social Insurance Premiums (National Pension Insurance
Pension	Premiums)

Those who paid National Pension Insurance Premiums from January 1 to October 2, 2023 will receive the "Deduction Certificate for Social Insurance Premiums (National Pension Insurance Premiums)" from the Japan Pension Service by mid-November.

Please keep it in a safe place as it will be required for year-end tax adjustments or tax returns.

Others

- -If you have paid National Insurance Premiums for family members, you can add them to your Social Insurance Premiums for a deduction.
- -Those who paid National Pension Insurance premiums for the first time this year between October 3 and December 31 will receive the deduction certificate early February.
