Tax payments must be made by law.

Municipal resident tax, property tax, national health insurance tax, and other taxes are used to create a safe and comfortable environment for everyone, including health, welfare, education, road maintenance, and garbage collection service. Please pay them by the due date.

If your payment is delayed...

You may be charged a late fee.

If you don't pay...

If you fail to pay tax and do not contact or consult with us after a notice, your property may be seized.



If your payment is delayed, contact us.

Those who are temporarily unable to pay their taxes may be eligible for a tax deferment. If you have any reason, please consult with us in advance.



Evenings and holidays are also available for consultation.

"eLTAX" for business owners

Corporate municipal resident tax and special municipal and prefectural resident taxes can be paid directly from your account of a financial institution registered on your PC in advance, and also paid to multiple municipalities at one time.

By Direct Debit (automatic transfer)

It's safe and convenient, as you don't have to worry about losing your payment slip or forgetting to pay.

Process

What to bring Bankbook, Bankbook seal, Notice of tax payment

Place At a bank or post office in the city in which you wish to direct debit.



At convenience stores

Payment can be made 24 hours a day.



Caution

- You cannot pay after the due date.

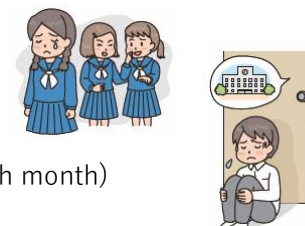

National Pension	Deduction Certificate for Social Insurance Premiums (National Pension Insurance Premiums)
