## Child Support Allowance for single-parent families, etc.

The Child Support Allowance (*jido fuyo teate*) will be provided to parents or caregivers whose children meet one of the following conditions. There are certain conditions, such as income limit, etc.

- Parents have divorced.
- Father or mother ①died, ②life or death unknown, ③detained for more than 1 year, or ④under a DV protection order.
- Abandoned by father or mother for more than 1 year.
- Father or mother has a severe disability.
- Born out of mother's wedlock.

※Eligible until the first March 31st of the child's 18th year old.

※The monthly allowance amount will be increased by 3.2% from April.

## Educational assistance for elementary and junior high school students

Subsidies will be provided to families with elementary or junior high school students who are having difficulty paying education expenses (school lunch fee, school supplies fee, etc.) for financial reasons.

**Eligibility**

- Those who receive the Child Support Allowance (*jido fuyo teate*)
- Those who are exempted from municipal resident tax.

**Application** Submit the application form (available at the school) to the school office.

※Those who moved to Fujinomiya City after January 2023 and do not receive the Child Support Allowance will be required the certificate of income tax, etc.

## Information on Seniors, Health, Medical Care, Nursing Care, and Disabilities

### Notice

### Pneumococcal vaccination for adults

Pneumococcal vaccine for adults is effective in preventing the onset and severity of pneumonia, bronchitis, sepsis, and other diseases.

You can receive one of these public subsidies once in your lifetime.

#### 【Regular vaccination】

**Eligibility** Those who have not received and meet one of the following conditions

- ①65 years old and older
- ②60-64 years old and with heart, kidney, respiratory or immunodeficiency disorders equivalent to grade 1 of the Physical Disability Certificate

**Fee** Copayment: 3,300 yen (free of charge for public assistance recipients)

**Application** Please see the information that will be sent in the month of birth for ①, in the month of birth for ②60 year olds, and in April for ②61 to 64 year olds.

#### 【Voluntary vaccination】

**Period** April 1 (Mon)-March 31 (Mon)

**Eligibility** Those 65 years old and older who have not received routine vaccinations.

**Fee** The amount of the vaccination cost minus 3,000 yen subsidized by the city

**Application** Please contact us in advance.

## Milestone checkups (periodontal disease, osteoporosis checkup)

Those who reach the milestone age can have periodontal and osteoporosis checkups.

### 【Periodontal disease checkup】

To avoid tooth loss due to periodontal disease, it is important to have regular checkups, early detection, and early treatment.

**Eligibility** Those living in the city who will turn 20, 30, 35, 40, 45, 50, 55, 60, 65, or 70 years old from April 2, 2024 to April 1, 2025

**Capacity** 30 people per day

**Fee** 410 yen (free for those who will turn 20 or 30 years old)

### 【Osteoporosis checkup】

Osteoporosis can be caused by a lack of calcium, a decrease in female hormones, lack of exercise, diet, and other factors.

**Eligibility** Those living in the city who will turn 30, 35, 40, 45, 50, 55, 60, 65, or 70 years old from April 2, 2024 to April 1, 2025

**Capacity** 45 people per day

**Fee** 510 yen

**Insurance premiums have been changed.**

Insurance premiums are calculated per individual based on the sum of the "Income-based amount" which is based on the insured person's income for the previous year, and the "Per capita amount," which is borne by all insured persons.
