Notice To all National Health Insurance members: For Reducing the burden of medical expenses

It is important to take care of your health by ensuring a good nutritional balance in your diet and having enough sleep on a regular basis. Also, please review the way you visit medical institutions.

Do not see more than one doctor for the same disease or symptom.

Repeating the same tests will result in extra medical costs.

Use generic medicines.

Generic medicines are inexpensive, generic versions of original medicines that are made with the same ingredients as original medicines after the patent period has expired, so using them can help you reduce your medicine costs.

Use over the counter medicines.

For mild symptoms, use over the counter medicines that can be purchased without a prescription.

Use the National Health Insurance card properly.

When you visit a medical institution for an injury caused by a traffic accident, etc., you cannot use the National Health Insurance unless you report it.

In addition, when visiting an osteoporotic clinic or orthopedic clinic, National Health Insurance cannot be used for pain in the shoulders, back or other parts of the body caused by internal organ diseases, or simply to relieve stiffness.
