### Cervical Cancer Screening

Cervical cancer is increasing among women in their 20s and 30s, and early detection before symptoms appear is important.

**Eligibility** Women who are citizens 20 years old and older, and who have not undergone cervical cancer screening in FY2024.

**Fee** 1,020 yen (Free of charge for those who will turn 21 years old in FY2025. Vouchers were sent by mail in May to eligible persons.)

## Subsidies for the purchase of hearing aids for the elderly

We subsidize a part of the purchase cost of hearing aids for those who have hearing loss and have been diagnosed by a doctor as needing them.

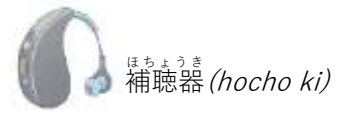
**Eligibility** Citizens 65 years old and older who meet all of the following conditions

- Those who have been examined by an otolaryngologist and diagnosed as needing hearing aids with a hearing level of 40 decibels or higher in both ears.
- Those who are not eligible for a physical disability certificate (*shintai shogaisha techo*) due to hearing impairment
- Those who are not subsidized for the purchase of hearing aids by other laws or regulations

**Details** Up to half of the purchase cost of the hearing aid (up to 30,000 yen)

**Application** Please come to the counter within 2 months after the purchase date of the hearing aid.

## To all members enrolled in the Medical Insurance for the elderly



■A new “Certificate of Eligibility (資格確認書)” will be mailed to you.

(The “Insurance Certificate (保険証)” will be switched to the “Certificate of Eligibility (資格確認書)”).

Your current “Insurance Certificate” / “Certificate of Eligibility (green)” will be expired on July 31 (Thu). New “Certificate of Eligibility (orange)” will be sent by mail in mid-July. If you do not receive it by July 31 (Thu), please contact us.

Please make sure that your name, address, and percentage of co-payment (10%, 20%, or 30%) are correct, and use the new “Certificate of Eligibility” from August 1 (Fri) to see a doctor.



New Certificate of Eligibility (orange) ▲

■The reduced amount certificate (white) and the limited amount certificate (yellow brown) have been abolished.

For those who currently have a reduced or limited amount certificate, a “Certificate of Eligibility” with the classification will be mailed to you.

If you do not have a certificate and wish to obtain a “Certificate of Eligibility” with “limit classification”, you must apply.

In addition, those who see a doctor with a MYNA insurance card do not need to apply.

**Application** Please come to the counter.

**What to bring** Personal seal, Identification document, “Certificate of Eligibility”, Proof of My Number.

Tax notices will be sent by mail in early August.

**■A tax notice will be mailed to you.**

Tax notices and payment slips will be sent to the head of household by mail in mid-July.

Please contact us if you receive a notice even though all household members are enrolled in Social Insurance.

**■The Insurance Certificate (保険証) <sup>ほけんしょう</sup> will be switched to a “MYNA insurance card” or a “Certificate of Eligibility (資格確認書) <sup>しかくかくにんしょう</sup>”.**

The current “Insurance Certificate”, “Certificate of Eligibility (light purple)”, and “Notice of Eligibility Information for those 70 years and older” will be expired on July 31 (Thu).

The “Notice of Eligibility Information” will be mailed to those who have a “MYNA insurance card”, and the “Certificate of Eligibility (light green)” to those who do not have the card, to the head of household by July 31 (Thu).

From August 1 (Fri), please use your “MYNA insurance card” or your “Certificate of Eligibility” to see a doctor.

Even though the elderly and persons with disabilities have a “MINA insurance card”, they can receive a “Certificate of Eligibility” if they apply for it.

If you have already received a “Certificate of Eligibility” after enrolling in Social Insurance or if you have withdrawn from Social Insurance and do not have a “Certificate of Eligibility”, you must apply for it at the counter.

## Renewal process for “Certificate of Eligibility for Ceiling-Amount Coverage”



If you use the “Certificate of Eligibility for Ceiling-Amount Coverage” at a medical institution, your co-payment amount is limited to the maximum amount.

The current certificates will be expired on July 31 (Thu). If you wish to continue using the certificate after August, please renew it.

**What to bring**

- “Certificate of Eligibility” for the applicant
- The certificate valid until July 31 (Thu) (if you have it)
- Proof of the head of household's and the applicant's MY number
- Identification document of the person visiting City Hall

**Application** From August 1 (Fri) at the counter

**Others** If you use your MYNA insurance card, your co-payment amount is automatically limited to the maximum amount, so you do not need to present your certificate at the reception desk.

**Wigs and Breast support items for cancer patients**  
**Subsidies for the purchase costs**

We subsidize a part of the purchase cost of medical support items that reduce the psychological burden on those whose appearance has been changed by cancer treatment.

Eligible items		Subsidy amount
Medical wig (for full head)		Maximum 20,000 yen
Breast support item *Either ① or ② only	① Shapewear (including bra pads)	Maximum 20,000 yen
	② Artificial breasts	Maximum 100,000 yen

**Eligibility** Citizens who had or are receiving cancer treatment and who meet all of the following conditions

- Those who purchased the item after April 2025
- Those who have not received the same subsidy in the past (including from other municipalities)

**Application** For purchases made from April through December, please come to the counter by March 31 (Tue), for purchases made from January through March, please come to the counter within 90 days from the day after the purchase date.

**What to bring** Please bring all of the following to the counter.

- Application form (available at Health Promotion Division or on the city's official website)
- Copy of document showing name of illness
- Copy of document showing hair loss or mastectomy due to cancer treatment (treatment instructions, medical certificate, treatment plan, etc.)
- Copy of receipt (with purchaser's name, purchase date, purchase amount, purchase details, Issuer's name, Issuer's address)
- Identification documents of the applicant
- Bankbook or cash card in the applicant's name

### National Pension

#### <National Pension Insurance Premium> Exemption and Deferment System



If you do not pay your National Pension Insurance premiums, you may not receive the "Old-age Basic Pension (*rorei kiso nenkin*)" in the future, or you may not receive the "Disability Basic Pension (*shogai kiso nenkin*)" or the "Survivor's Basic Pension (*izoku kiso nenkin*)" when an unexpected event occurs.

If you are having difficulty paying the premiums for financial reasons, you may use the exemption or deferment system.

The period in which full exemption or deferment is granted upon application is calculated as the eligibility period.

#### Exemption

If the income of the applicant, spouse, or head of household is below a certain level, he/she is exempted from paying the full amount or a part of it according to his/her income.

※If you are approved for other than full exemption, you must pay the remaining premiums otherwise you will be classified as unpaid.

#### Deferment

If the income of the applicant under 50 years old and their spouse is below a certain level, the payment of premiums is deferred.

In addition, students may also apply for a special exception to premium payment.

- Pension Handbook (*Nenkin techo*), Basic Pension Number Notification (*Kiso Nenkin bango tsuchisho*) or MY Number Card
- ID (driver's license, etc.)
- Certificate of eligibility for employment insurance (if you are unemployed)
