Tax payments must be made by law.

Tax payment is a civic duty. City resident tax, property tax, national health insurance tax, and other taxes are used to create a safe and comfortable environment for everyone, including health, welfare, education, road maintenance, and garbage collection service.

Please pay them by the due date.

If your payment is delayed...

You will be charged a late fee.

If you don't pay...

If you fail to pay your tax and do not contact or consult with us even after a notice, your property may be seized.



If you cannot pay by the due date, contact us.

If you have special circumstances or cannot pay by the due date, please consult with us as early as possible.

Corporate city resident tax and special city and prefectural resident taxes can be paid directly from a financial institution's account via the internet, and can be paid to multiple municipalities at once.

Process

Place At a bank or post office in the city in which you wish to direct debit.

Welfare Loan Program for single-parent families



ID 577

The prefectural government provides interest-free loans to single-parent families whose children are enrolling in high school, university, or vocational school.

The loan limit varies depending on the type of school, public or private school and commuting conditions, etc.

■ School fees

Tuition, Commuting fees, etc.

■ Enrollment fee, etc.

Preparation fee to enroll in high school, university, or vocational school



Eligibility

- Children from single-parent families
- Orphans under age 20

Application Application forms are available/distributed and accepted at the counter of the Children's Future Division on the 1st floor of City Hall.

Others Parent-child interviews will be held at a later date. This loan program cannot be provided to students who are using a scholarship program such as "IKUEIKAI", etc.

- Those from households exempt from the city resident tax (Please contact the Health Promotion Division in advance)
- Recipients of public assistance
- Those turning 21 this fiscal year (coupons were sent in May)
- Those aged 70 or older on the day of their appointment
- Members of the Medical Health Insurance for the elderly

National Pension

Deduction Certificate for Social Insurance Premiums (National Pension Insurance Premiums)

The Japan Pension Service will mail the "Deduction Certificate for Social Insurance Premiums (National Pension Insurance Premiums)" to those who have paid National Pension Insurance premiums from January to September 2025.

Please keep it in a safe place as you need it for your year-end tax adjustment or tax return.

Others

- If you have paid the National Pension Insurance premiums for a family member living with you, you can add this amount to your social insurance premium deduction.
- Those who paid National Pension Insurance premiums for the first time between October and December of this year will receive the deduction certificate in February.

Two types of PINs are required when you use your My Number Card.

- **Electronic certificate for signature** (6 to 16-digit uppercase letters and numbers)
- **Electronic certificate for user proof** (4-digit number)

If you forget your PIN or your electronic certificate has expired, you can reset or renew it at the Citizen Registration Division on the 1st floor of City Hall or at any branch office.
