Final Income Tax Return



Who needs to file a final income tax return?

The main examples are listed below:

Those with salary income

- Those receiving salary from two or more employers (Those whose salary is 200,000 yen or more and who have not completed year-end tax adjustments)
- Those with annual income of 200,000 yen or more from sources other than salary
- Those with annual salary income of 20,000,000 yen or more

Those with profits from business income

- Those with income from business operations, farming, real estate, etc.
- Those who trade stocks in a general account and earn profits

Those who need to file a final income tax return→



Those with public pension income

- Those with public pension income of 4,000,000 yen or more
- Those with annual income of 200,000 yen or more from sources other than public pensions, such as salary income or private pension income

Those with temporary income

- Those who received lump-sum payments from life insurance, horse racing dividends, etc.
- Those who sold land or buildings

If you want to know the types of income→



Those who receive income deductions or tax refunds must also file a final income tax return.

Medical Expense Deduction

- Those whose annual medical expenses for themselves and dependents living in the same household exceed 100,000 yen

The amount exceeding 100,000 yen can be deducted from income.

※If the previous year's income was less than 2,000,000 yen, the amount exceeding 5% of income can be deducted.

Example: A person with previous year's income of 1,500,000 yen is 75,000 yen (1,500,000 yen × 5%)

To those enrolled in National Health Insurance:

A "Medical Expense Notice" listing medical expenses for November and December 2025 will be sent in late February. If you wish to claim medical expense deductions before receiving that notice, please use your receipts.

Donation Deduction

- Those who made hometown tax donations to more than five municipalities and did not file a one-stop special application
- Those who made donations to specific organizations

※Even if you filed a one-stop special application for hometown tax donations, you must include hometown tax donations in your application if you file a final income tax return.

Mortgage Deduction

- Those who begin residing in their home by December 31, 2025, and are claiming a mortgage deduction for the first time
(Certain requirements apply to receive the deduction.)
From the second year onward, you can claim it through year-end tax adjustments.

Those who may be eligible for income deductions or tax refunds

- Those who quit their job in the middle of the year and did not complete year-end tax adjustments, or those whose income from part-time jobs, side jobs, or freelance work is subject to withholding tax, may be eligible for a refund by filing a final income tax return.
※Filing a final income tax return may also result in additional tax payments.
- Those whose only income is from public pensions, but who have had tax withheld and have received deduction certificates for social insurance premiums or life insurance premiums may be eligible for a refund by filing a final income tax return.



It's time for final income tax returns!

At the tax return venue and the information session venues, you will file your tax return yourself using your smartphone and My Number Card.

Tax office staff will assist those with pension income and those filing for a mortgage deduction for the first time in preparing their tax returns. Please bring the documents listed on page 4 that are required for filing your tax return.

- Applications will be accepted via LINE starting 14 days prior to your desired date.
- Numbered tickets distributed at the venue on the day of the event



Distribution will end once the capacity is reached at any venue.

Those aged 65 or older residing in the city with pension income, and those with disabilities, can file their tax returns at City Hall.

An appointment is required for filing. No admission numbered tickets will be distributed on the day.

For those with business or real estate income and whose 2025 income is 3,000,000 yen or less, or whose 2023 sales are 30,000,000 yen or less, tax accountants will offer free consultations.

Required items for filing

- Smartphone
- Documents required for calculating income, such as withholding tax slips (*gensen chosyu-hyo*)
- Certificates required for deductions, such as statements for social insurance premiums ^{※1}, life insurance premiums, earthquake insurance premiums, and medical expenses ^{※2}

※1 Notice of Amount Paid

We will mail the statement showing the amount paid for National Health Insurance tax, Long-Term Care Insurance premiums, and Medical Insurance for the Elderly premiums for the year 2025 in late January.

※2 In order to claim the medical expense deduction, you must attach your "Medical Expense Deduction Statement."

The statement can be obtained at the Citizen's Tax Division (*Shimin zei-ka*), Fuji Tax Office counter, or downloaded from the National Tax Agency website.

Medical expense receipts may be requested by the tax office at a later date. Please keep them for five years.

※If you attach the "Medical Expense Notification" issued by your health insurance provider, you may be able to omit filling out the medical expense deduction statement.

- Bank account information (in your name)
※If you received a refund on your tax return
- Your copy of the previous year's tax return (if you have)
- My Number Card
※If you do not have it...
Personal Number verification documents (My Number notification letter, Residence Certificate with My Number, etc.) and ID card with photo issued by a public agency ^{※3} (Driver's license, Residence Card, Disability Handbook, etc.)

※3 If your ID has no photo, two types of documents are required.

Those claiming the mortgage interest deduction...

The required documents vary depending on the criteria, such as the "Year-End Mortgage Balance Certificate" sent by the financial institution from which you borrowed, and a copy of the house purchase (or construction contract) agreement.

If applying on behalf of someone else...

A power of attorney, the applicant's personal identification number verification documents, and the agent's identification documents are required.

Don't forget file your Municipal and Prefectural Resident Tax Returns by March 16 (Mon).

Those who must file a resident tax return : (Excluding those who have already filed their final tax return)

Those whose income other than public pensions or salary income is 200,000 yen or less

The following persons are not required to file a tax return. However, by filing, they may be eligible for tax deductions or refunds and can receive a certificate.

- Those who want to claim income deductions such as medical expense deductions or social insurance premium deductions
- Those who want to receive reductions in National Health Insurance tax or medical insurance premiums for the elderly
- Those who need an income certificate for applications such as nursery school enrollment or municipal housing

Submission by mail

Please check the contents of your application and mail it with the required documents enclosed.

Tax return forms are available at the tax filing venues, at the Citizen's Tax Division counter on the first floor of City Hall, and on the city's official website.




You don't want to waste time, right?

There are several ways to complete the procedures without visiting City Hall.

From February to May every year, City Hall counters become extremely crowded as many people visit to complete moving-in/out procedures and obtain certificates required for school enrollment.

If you have your My Number Card, you can complete procedures without visiting City Hall by using Myna portal, internet services, or convenience stores.



When using your My Number Card for procedures, you will need your PIN.

If you can't remember your PIN→



Applications for moving outside the city can be submitted anytime, 24 hours a day, from 14 days prior.

You can use the Myna Portal to submit your moving-out notification and make an appointment to complete your moving-in notification at your new local city hall.

| <p>All persons aged 20 to 59 who reside in Japan are obligated by law to enroll in the National Pension System. Pension benefits are provided as income security in old age, as well as in the event of death or disability due to illness.</p> <p>When you turn 20, you will receive a “Notice of National Pension System Enrollment” and a “Notice of Basic Pension Number” from the Japan Pension Service. (Excluding those enrolled in the Employees’ Pension System)</p> <p>The Notice of Basic Pension Number is necessary for confirming your premium payments and for receiving your pension in the future. The subsidy program for combined sewage treatment tanks will change.

Ending in FY2025

The subsidy program for installing or replacing combined sewage treatment tanks when building a house or expanding/renovating a house will end.

Starting in FY2026

The subsidy program for replacing existing individual sewage treatment tanks or pit toilets with combined sewage treatment tanks is planning to expand.

Switch to a combined sewage treatment tank!

Individual sewage treatment tanks can only process wastewater from toilets. It is important to replace them with combined sewage treatment tanks, which can process all types of wastewater and are environmentally friendly.
