Postpartum Care Services & Childcare Support Helpers Are Now Available More Often!

We have expanded our support services, increasing the usage period and number of visits. Even if your child is over one year old, you can apply for additional vouchers or submit a new application.

Postpartum Care Services

- ◆ Daycare centers (short-term) and in-home care services are available until the day before your child's second birthday.
- ◆ Three additional vouchers for daycare centers (short-term) and in-home care services will be provided, totaling eight vouchers.
- ◆ Starting April 1, the usage fee is 2,000 yen for daycare centers (short-term) and home visit services, and 11,000 yen for overnight stays.

Childcare Support Helpers

- ◆ Available until the day before the child's second birthday.
- ◆ A total of 100 vouchers (100 hours) can be used.

The shingles virus lies dormant in over 90% of Japanese adults, and about one in three will develop it by the age of 80. Vaccination is effective in preventing its onset and severe symptoms.

Eligibility

- ① Those who have not received the vaccine and are reaching the age of 65, 70, 75, 80, 85, 90, 95, or 100 during this fiscal year.
- ② Those who have not received the vaccine and aged 60 to 64 with immunodeficiency caused by HIV (human immunodeficiency virus), which is equivalent to Grade 1 of the Physical Disability Certificate

**< National Pension >
"Special Payment System for Students"**



In Japan, even students are obligated to enroll in the National Pension System and pay premiums once they turn 20. However, since students generally have low incomes, those whose income is below a certain amount can postpone their payments by using the "Special Payment System for Students".

Students who turn 20 during FY 2026

Please apply if you have difficulty paying the premiums.

What to bring A copy of your student ID (both sides) or a certificate of enrollment

Application After your 20th birthday, please complete the procedures using the "Application for Special Payment System for Students" enclosed with the payment slips sent by the Japan Pension Service.

Others The period during which you use the "Special Payment System for Students" is also the qualification period for receiving the "Old-age Basic Pension" in the future, but it will not be reflected in the amount of your pension.

If you wish to increase your future pension amount, please make additional payments within 10 years.

Those who renovate their homes can receive “Miya Coupons” that can be used at stores within the city. Child-rearing households and households planning to start living together as a three-generation family are eligible for an additional amount.

◆Coupon Amount

Coupon Type	Subsidy Amount
①General	100,000yen
②Child-rearing households (with preschool children or pregnant women)	150,000yen
③Three-generation household(newly starting co-residence)	200,000yen

Eligibility Applicants must meet all of the following criteria:

- Own and reside in a home within the city.
- Have no outstanding municipal tax payments.
- The renovation costs must be 300,000 yen or more.
- The renovation must be performed by a contractor whose head office is located within the city.
- Construction must begin on or after April 1 (Wed) and be completed by November 30 (Mon).

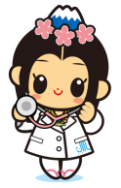
