National Pension

<National Pension Insurance Premium> Exemption and Deferment System



If you do not pay your National Pension Insurance premiums, you may not be able to receive the "Old-age Basic Pension (*rorei kiso nenkin*)" in the future. In addition, you may not be eligible to receive the "Disability Basic Pension (*shogai kiso nenkin*)" or the "Survivor's Basic Pension (*izoku kiso nenkin*)" if an unexpected event occurs.

If you have difficulty paying your premiums for financial reasons, you can apply for the exemption or deferment system.

The period for which a full exemption or deferment is granted will still count toward your pension eligibility period.

Exemption

If the income of the applicant, their spouse, or the head of the household is below a certain level, the applicant may be fully or partially exempted from premium payments based on their income level.

*If you are approved for other than full exemption, you must pay the remaining premium amount. Otherwise, your premiums will be treated as unpaid.

Deferment

If the income of an applicant under the age of 50 and their spouse is below a certain level, premium payments may be deferred.

Additionally, students can apply for a special payment exception (the Special Payment System for Students)

■ A new "Certificate of Eligibility (資格確認書)" will be mailed to you.

Your current "Certificate of Eligibility (olive green)" and "Notice of Eligibility Information" for those aged 70 or older will expire on July 31 (Fri). For those without a Myna health insurance card, a new "Certificate of Eligibility (light yellow)" will be mailed to the head of the household by July 31. Please use the new certificate when visiting medical institutions from August 1 (Sat).

※Elderly individuals or persons with disabilities can still receive a Certificate of Eligibility upon request, even if they have a Myna health insurance card.

※Procedures at the counter are required if you receive a Certificate of Eligibility after enrolling in social insurance, or if you do not have one after withdrawing from social insurance.

■ For those who have a Myna health insurance card:

Aged 70 or older: A "Notice of Eligibility Information" including your co-payment rate will be mailed to you.

Under 70 years old: If you already have a Notice of Eligibility Information, a new one will not be mailed. Please present the notice together with your Myna health insurance card if the card cannot be scanned due to equipment failure or other issues at medical institution counters.

■ A notice regarding insurance tax and payment methods will be mailed to you.

The notice will be mailed to the head of the household in mid-July. If payment slips are enclosed, please make your payment at a financial institution counter or a convenience store by the due date.

■ Renewal of the "Eligibility Certificate for Ceiling Amount (限度額適用認定証)" for those without a Myna health insurance card

If you do not have a Myna health insurance card, presenting this certificate at a medical institution will limit your out-of-pocket medical payments to a maximum ceiling amount.

Your current certificate will expire on July 31 (Fri). If you wish to continue using it from August onwards, please complete the renewal procedures.

※ This procedure is not required for those aged 70 or older whose income category falls under "General (一般)" or "Standard Income Earners III (現役並みⅢ)".

We subsidize a part of the purchase cost of medical support items that reduce the psychological burden on those whose appearance has changed due to cancer treatment.

Eligibility

Residents who have undergone or are currently undergoing cancer treatment, and who meet all of the following criteria:

- Those who purchased the eligible item on or after April 1, 2026.
- Those who have not received the same subsidy before (including from other municipalities)

Application

- Purchases from April to December: Please apply at the counter by March 31 (Wed).
- Purchases from January to March 2027: Please apply at the counter within 90 days from the day after the purchase.

What to bring

Please bring all of the following to the counter:

- Application form (available at the Health Promotion Division or on the city's official website)
- A copy of document stating name of the illness
- A copy of document confirming hair loss or a mastectomy due to cancer treatment (e.g. treatment instructions, medical certificate, treatment plan)
- A copy of the receipt (showing the purchaser's name, purchase date, purchase amount, item details, Issuer's name and address)
- The applicant's Identification Document (ID)
- A bankbook or cash card in the applicant's name.

New Marriage Life Support Subsidy

We provide subsidies for newlywed residents to cover their housing and moving expenses.

Subsidy Amount

- Households where both spouses are aged 34 or younger as of the date of marriage: Up to 600,000 yen
- Other households: Up to 300,000 yen

Eligibility Couples who registered their marriage between January 1, 2026 and February 28, 2027, and meet all of the following criteria:

- The couple's combined annual income for the most recent year is less than 5,000,000 yen.
- Both spouses are aged 39 or younger as of the date of marriage.
- As of the application date, at least one spouse is registered as a resident in the city where he/she actually resides.
- Both spouses plan to reside within the city for at least one year.
- The couple has not received the same subsidy before (including from other municipalities).
- Neither spouse is delinquent on city taxes.
