Current Status Report for Child Allowance (*jido teate*)

Those who are required to submit the current status report (*genkyo todoke*) will receive the form by mail in mid-June. Please submit it by **June 30 (Tue)**.

In principle, you do not need to submit this report if there are no changes in your child's care status.

Procedures are required in the following cases:

- When the recipient moves out of the city
- When the recipient and the child live at different addresses
- When the recipient becomes a civil servant

Others If your procedures are delayed, you may be required to refund the allowance.

Medical Expense Subsidies for Single-Parent Households, etc.

When you receive medical treatment covered by health insurance, we will subsidize the full amount of your co-payment.

Eligibility Households that meet one of the following conditions and whose income for 2025 was exempt from income tax.

- ① Single parents who support children under 20 years old, and their children
- ② Children under 20 years old who have no parents
- ③ Children under 20 years old whose father or mother has a severe disability, or who cannot receive parental support due to a parent's prolonged detention or disappearance

What to bring

- Bankbook in the name of the parent or guardian
- Health Insurance cards of all household members
- My Number (individual number) of all household members

Pension

In Case of Disability Due to Illness or Injury



If you are enrolled in the National Pension System and you have a disability caused by an illness or injury, you may be eligible to claim the Disability Basic Pension.

Eligibility Those who are certified as having a designated level of disability as defined by the National Pension Act, and who meet one of the following conditions:

- (1) Those who were enrolled in Category 1 of the National Pension System (e.g., self-employed individuals, students, the unemployed, etc.) on the date of their first medical examination.
- (2) Those who were 19 years old or younger, or between 60 and 64 years old, and were not enrolled in the Pension System on the date of their first medical examination.
- (3) Those who were enrolled in Category 3 of the National Pension System (e.g., dependent spouses of employees, etc.) on the date of their first medical examination.

Others Certain payment requirements must be met.

If you were enrolled in the Employees' Pension System on the date of your first medical examination, please contact the Pension Office.
